

PEPFAR AND IMPACT ON THE WORLD AND INDIA: GS-III

Since its inception, PEPFAR has:

- Invested **over \$100 billion** in HIV/AIDS relief worldwide.
- Supported **over 20.6 million people** with ART.
- Facilitated **HIV testing for 83.8 million people globally**.
- Provided **pre-exposure prophylaxis** (**PrEP**), a preventive treatment for HIV, to **2.5 million people**.
- Accounted for nearly 90% of PrEP initiations worldwide.

PEPFAR has enjoyed bipartisan support in the U.S., given its tremendous impact in reducing HIV transmission rates and preventing millions of deaths.

Recent Freeze on PEPFAR Funding and Emergency Waiver

The U.S. State Department, under the new Donald Trump administration, recently announced a 90-day freeze on all foreign funding, including PEPFAR, as part of a broader review of foreign aid programs.

The stated reason for the funding freeze is to evaluate:

- The efficiency of aid programs.
- The alignment of these programs with U.S. foreign policy.

However, given the critical role of PEPFAR in global HIV/AIDS relief, concerns arose about its impact on millions of patients who depend on it for treatment.

To mitigate immediate risks, U.S. Secretary of State Marco Rubio approved an emergency waiver, ensuring that:

- Patients already receiving ART continue to get their medication.
- Ongoing treatment plans remain unaffected while the policy review is conducted.

Despite this waiver, uncertainties remain regarding the long-term continuity of PEPFAR funding, leaving many partner countries and public health experts worried.

Impact of the Freeze on Global HIV/AIDS Programs

The temporary halt on PEPFAR's funding is **expected to affect numerous regions**, particularly in **Africa**, where the program has been most impactful. Key consequences include:

1. Disruption in HIV Treatment

Many developing nations depend heavily on PEPFAR for access to anti- retroviral therapy (ART).

- 2. Setback in HIV Prevention Efforts
 - o PEPFAR funds **HIV testing, education, and prevention programs**.
 - A funding freeze could reduce testing rates, leading to higher HIV transmission.
- 3. Threat to Pre-Exposure Prophylaxis (PrEP) Programs
 - Nearly 90% of global PrEP users rely on PEPFAR-backed programs.
 - Any reduction in funding could weaken preventive measures, causing a rise in new infections.
- 4. Weakened Public Health Infrastructure
 - Many countries have built their HIV response frameworks with PEPFAR support.
 - The funding freeze could slow down future research and weaken health systems.

While the emergency waiver helps sustain ART treatment, other key services like testing, prevention, and outreach may still be at risk if funding remains uncertain.

Impact of PEPFAR's Freeze in India

India, while not a major beneficiary of PEPFAR funding like African nations, still receives indirect support through pilot projects and technical collaborations. Here's how the funding freeze could impact India:

- 1. Minimal Effect on ART and HIV Testing
 - o India's HIV/AIDS program is mostly government-funded, with ART and testing services provided through the National AIDS Control Organisation (NACO).
 - Since PEPFAR does not directly fund ART in India, the freeze won't significantly impact treatment access.
- 2. Disruption in Research & Pilot Projects
 - PEPFAR supports innovative pilot programs such as:
 - Project Sunrise: Helps injecting drug users in Northeast India.
 - Project Sunshine: Works on epidemic control strategies in Manipur, Mizoram, and Nagaland.
 - Accelerate Program: Focuses on HIV prevention in six high-risk Indian states.
 - These projects may face delays or suspension, affecting new strategies for prevention and control.
- 3. Temporary Disruptions in Digital Outreach Programs
 - SafeZindagi, a PEPFAR-backed virtual HIV awareness and testing platform, has become temporarily unavailable due to funding issues.
 - This could affect online outreach, at-home testing kits, and preventive PrEP distribution.

While India's national AIDS control efforts remain intact, research and technical collaborations may suffer setbacks if PEPFAR funding remains uncertain.

India's Unique Position in HIV Control

India is **one of the few developing countries** with a **strong, government-funded HIV/AIDS program**. Some of its **unique strengths include**:

- **Self-reliance in ART production**: India manufactures **low-cost ART drugs** used worldwide.
- Comprehensive National AIDS Control Program (NACP): Covers prevention, treatment, education, and community outreach.
- Strong surveillance network: Allows early detection and prevention of HIV outbreaks.
- Integration with universal healthcare programs, ensuring free HIV services for vulnerable groups.

These strengths cushion India from major disruptions, making it less dependent on external aid like PEPFAR compared to many African nations.

Implications of the PEPFAR Freeze

The temporary pause on PEPFAR funding highlights broader concerns about:

- 1. Uncertainty in Global Health Aid
 - o The freeze signals **potential shifts in U.S. foreign aid policies**, creating instability in global HIV/AIDS funding.
- 2. Need for Alternative Funding Models
 - Countries dependent on PEPFAR may need to explore alternative funding through partnerships with WHO, UNAIDS, and private donors.
- 3. Reinforcement of Domestic HIV Programs
 - o Countries must strengthen their internal HIV response mechanisms to reduce reliance on foreign aid.
