4. First India-Egypt Strategic Dialogue - International Relations

Resolution of Palestinian question necessary for India-Middle East-Europe-Economic Corridor - Egyptian FM. The first India-Egypt Strategic Dialogue discussed strengthening bilateral ties and regional connectivity through the India-Middle East-Europe Economic Corridor (IMEC), while reaffirming India's support for the two-state solution for Palestine. IMEC aims to enhance trade, strategic partnerships, and energy security by connecting India with the Middle East and Europe via ports, railways, and pipelines, though geopolitical, financial, and technical challenges remain.

India-Egypt Strategic Dialogue & India-Middle East-Europe Economic Corridor (IMEC)

1. Context - The first India-Egypt Strategic Dialogue was held in New Delhi.

Co-chairs - EAM Dr. S. Jaishankar (India) and Egyptian FM.

Primary discussion - Progress and cooperation on the India-Middle East EU Economic Corridor (IMEC).

- 2. Egypt's Position on Regional Connectivity Egypt supports regional connectivity projects like IMEC. However, it believes progress is contingent on addressing the Palestinian question. Proposed India's participation in the Egyptian Suez Canal Economic Zone (SCZONE), where countries like Russia and China already have industrial complexes, to strengthen connectivity and trade cooperation.
- 3. India's Support to Palestine India reiterated its consistent backing of the two-state solution peaceful coexistence of Israel and Palestine as independent states.
- 4. Egypt's Geostrategic Role Acts as a bridge between Asia, Africa, and Europe. SCZONE provides industrial and trade cooperation opportunities. Played a role in Gaza Peace Agreement (2025) as a mediator, enhancing its centrality in Middle East peace efforts and connectivity diplomacy.
- 5. India-Egypt Relations Diplomatic relations established at Ambassadorial level 1947. Founding members of Non-Aligned Movement (NAM) 1961.

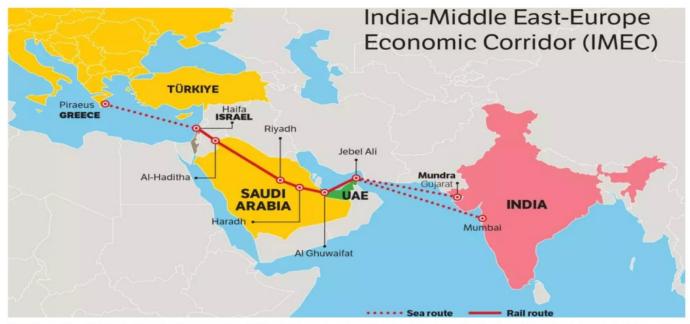

Policy Alignment - Supports India's "Act West Policy."

Energy Security - Facilitates integration of energy pipelines and green hydrogen networks.

Eco-friendly Infrastructure - Emphasis on sustainable development.
